Sale Conditions

The deadline for cutting and removing the timber will be February 28th, 2028. Notification must be given to agent or owners prior to cutting. All roads as shown on the attached map must be cleared and repaired to as good or better than their present condition. No skidding or grading down below it's natural grade will be allowed on the "primary roads" shown on the sale map. No excessive rutting will be allowed. All merchantable timber may be cut within the clear-cut sale area shown on the sale map less and except a few hardwood trees flagged with orange flagging around the cemetery area. Care must be taken not to excessively damage these trees flagged with orange flagging and the remaining timber within the SMZ areas. Mississippi BMP's should be followed. Any severance taxes due must be paid by the purchaser.





Timber Sale Map
